TERMS AND CONDITIONS FOR RUNNING THE MESS IN NSTI (W) CANTEEN  
AT NATIONAL SKILL TRAINING INSTITUTE (WOMEN), BENGALURU-560 029

The successful Contractor is to execute an AGREEMENT with the Regional Director, NSTI (W), BENGALURU, to run the above Mess as per the following terms and conditions.

01	The Contractor has to deposit a sum of Rs. <b>20,000/-</b> (Rupees Twenty Thousand only) as <b>SECURITY DEPOSIT</b> for running the Mess. The money is refundable (without any interest thereon) to the Contractor at the end of satisfactory completion of the Contract.
02	The food is to be served against CASH or according to any other system as may be decided by the Contractor with the approval of the Regional Director.
03	The Contractor will be provided with inventories like furniture, LPG Gas Stoves, Cylinder and utensils as available in the Institute. Water shall be provided by the Institution.
04	Cleanliness and proper up-keep of the premises and utensils, etc. will be the responsibility of the Contractor. All electrical, water and gas fittings are to be maintained by the Contractor. Electrical and fire safety shall be ensured by the Contractor at his cost.
05	Any damage/loss caused to the Government property entrusted to the Contractor shall be fixed by him.
06	The Contractor shall not alter, modify, any of the installations without written permission from the Regional Director.
07	The Breakfast, Lunch & Dinner etc. is to be served at the timings fixed by Regional Director.
08	The menu items to be included in the Breakfast, Lunch and Dinner etc., are to be decided by the Regional Director in consultation with the Contractor.
09	The Contractor shall supply the food as per the quantity and quality agreed by him on all the 7 days in a week including Holidays.
10	The Mess hall, kitchen and other places should be properly cleaned and maintained in hygienic condition & applied with Disinfectants wherever required.
11	The Contractor shall make his own arrangements for the employment of men required for running the mess and it shall be entirely and solely his responsibility towards payment of wages etc.,. Persons employed by him should be free from communicable diseases. No child labour is permitted in the Canteen.
12	The details of persons deployed by him shall be given to the office. Outsiders & unauthorized persons shall not be allowed inside Canteen premises.
13	The Mess shall be run by the Contractor alone and he shall not sublet to anyone else to run the same on his behalf.
14	Grievances/ complaints of the participants/ employees/ guests to be registered by the Contractor.
15	Consumption of Alcoholic drinks and Smoking shall not be permitted in the Canteen premises.
16	The period of contact will be for a period of <b>ONE YEAR</b> . The rates quoted are valid for one year from the date of signing the Contract. The Contract may be extended at the discretion of the authorities subject to mutual agreement.
17	In case, the Mess Contractor fails to run the Mess as agreed and Institute is compelled to cancel the contract, the Security Deposit shall stand forfeited.
18	The decision of the Regional Director, NSTI, Bengaluru with regard to any clarification on this Contract is final and shall be binding on the contractor.
19	The Contractor shall not be permitted to use Electric heaters. Electricity is to be used only for lighting/ Domestic purpose.
20	The Contractor has to pay a monthly charges of Rs. <b>3,000/-</b> per month towards utilizing the infrastructural facilities provided by this Institute & shall obtain receipt for the same.
21	The Tenderer may quote the details and rates and being offered by him for the listed Menu items, in the format enclosed.
22	The Tenderer shall follow strictly all guidelines issued from State Govt. <b>Regarding Food Safety and Standards time to time.</b>
